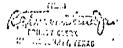

## GENERAL LAND USE

## COVENANTS APPLYING TO THE LAND

It is expressly provided that one owner of two adjacent residential lots, or parts thereof, may build one structure on the two lots or parts thereof, in accordance with this restriction in which event the outer lot lines of the building site thus created will be considered the side lot lines for all purposes herein, provided, however, that the partition of adjacent lots shall create no lot having a front footage of less than sixty (60) feet, or no lot having an area of less than seven thousand (7000) square feet,

- A. No building shall be erected, placed, or altered on any residential let until the construction plans and specifications and a plan showing the location of the structure have been approved by the Architectural Constrol Committee referred to below. This approval shall include conformity and harmony of external design with existing structure in this substitution, and as to location of the building with respect to topography and finished ground elevation.
- There is hereby created an Architectural Control Committee which shall bo composed of three (3) members. The initial members shall be JAMES E. LYON, ELTON BRIMBERRY AND R. W. CAREY. A majority of the committee may designate a representative to act for the committee. In the event of death or resignation of any member of said committee, the remaining member, or members shall have full authority to designate and appoint a successor, or representative with like authority. Neither the members of such committee, nor its designated representative, shall be entitled to any compensation for services performed pursuant to this covenant. The powers and duties of such committee, and of its design nated representative, shall cease January 1, 1985. Thereafter the powers and duties of such committee described herein shall not be required, unless, prior to said date and effective thereon, a written instrument shall be executed by the then record owners of a majority of the lots in the sub-division and duly recorded, appointing a representative, or representatives, who shall thereafter exercise the same powers previously exer-· cised by said committee.

The committee's approval or disapproval of any matter herein provided for shall be in writing. In the event said committee, or its designated representative, fails to approve or disapprove, in writing, within thirty (30) days after any plans and specifications have been submitted to it, or in any event, if no suit to enjoin the erection under any such plans and specifications, or the making of any alterations, shall have been commenced prior to the completion thereof, such approval will not be required and this covenant shall be deemed to have been fully complied with.

## 3. SIZE AND LOCATION OF STRUCTURES AND MATERIALS:

A. No building shall be located on any residential lot nearer to the front lot line or near to the side street line than the minimum building set—back lines shown on the recorded plat; and not less than five (5) feet from the side property lines, provided, however, that in the case of detached garages, the building line shall be three (3) feet from the side property line. No fence shall be erected nearer to the front line than the minimum building set back lines shown on the recorded plat.

B. The ground floor area of any one story main residence structure, exclusive of open porches and garages, shall not be less than one thousand four hundred (1,400) square feet.

The ground floor area of any one and one-half (11/2) story main residence building, exclusive of porches, garages, storage rooms, and/or servants quarters, shall not be less than one thousand (1000) square feet and the upper floor area shall not be less than four hundred (400) square feet.

- C. All buildings shall be brick veneer or natural stone veneer construction. Without in any way limiting the provisions of the preceding sentence, it is expressly provided that no exterior walls of any dwelling shall be constructed of asbestos shingles, concrete blocks or stucco. The type of exterior walls to be constructed in any dwelling unit must be approved in writing by the Architectural Control Committee before construction is begun.
- D. Main dwelling shall be constructed fronting on the street upon which the lot, as originally dedicated, fronts.

## 4. TEMPORARY STRUCTURES:

No structure, trailer, basement, tent, shack, garage, barn, or other outmoulding shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence, except that builders actually engaging in the construction of residences on any of the property shall be entitled to erect and maintain temporary buildings necessary in connection with such construction, provided, however, that all such temporary buildings must be removed from the property not later than December 31, 1965.

No noxious or offensive trade or activity shall be carried on upon any residential lot, nor shall anything be done thoroon which may be or beacome an annoyance or nuisance to the neighborhood.

No spiritous, vinous, or malt or medicated bitters capable of producing intoxication shall over be sold, or offered for sale on any residential lot or any part thereof, nor shall said property or any part thereof be used for illegal or immoral purposes.

#### 6. SIGNS:

No sign of any kind shall be displayed to the public view on any lot except one sign of not more than five (5) square feet advertising the property for sale or rent, or large signs used by a builder to advertise the property during the construction and sale period.

#### 7. EASEMENTS:

Easements for installation and maintenance of utilities and drainage facilities are reserved as shown on the recorded plat.

## 8. OIL AND MINING OPERATIONS:

No oil drilling, oil development operations, oil refining, quarrying, or mining operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, mineral excavations or shafts be permitted upon or in any lot. No derrick or other structure designed for

# 9. LIVE STOCK AND POULTRY:

No animals, livestock, fowl, rabbit, or poultry of any kind, shall be raised, bred or kept on any lot, except that dogs, cats or other housewhold pets may be kept provided they are not kept, bred or maintained for any commercial purpose.

# 10. GARBAGE AND REFUSE DISPOSAL:

No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage or other waste shall not be kept except in sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.

# 11. SIGHT DISTANCE AT INTERSECTIONS:

No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between two (2) and six (6) feet above the roadways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street property lines and . line connecting them at points twenty-five (25) feet from the intersection of the street lines, or in the case of a rounded property corner from the intersection of the street property lines extended. The same sight line limitations shall apply on any lot within ten (10) feet from the intersection of a street property line with the edge of a driveway or alloy pavement. No tree shall be permitted to remain within such distances of such intersections unless the foliage line is maintained at sufficient height to pre-vent obstruction of such sight lines.

## 12. TERM & ENFORCEMENT:

These covonants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of twenty-five (25) years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive permicles of ten (10) years, unless an instrument signed by a majority of the then owners of the lots, has been recorded, agreeing to change said covenants in whole or in part.

Enforcement shall be by proceedings at law or in equity against any person or persons violating or attempting to violate any covenants, either to restrain violation, or to recover damages. Invalidation of any one of these covenants, either by judgment or court order, shall in no wise affect the other prosisions which shall remain in full force and effect.
