Rental of such servants quarters hovever, is strictly prohibited. However, it is expressly provided that one owner of two adjacent lots, or parts thereof, may build one attructure on the two lots or parts thereof, in accordance with this restriction in which event the outer lot lines of the building site thus created will be considered the side lot lines for all purposes herein, provided, however, that the partition of adjacent lots No lot shall be used except for residential purposes. No building for all purposes herein, provided, however, that the partition of adjacent lots shall create no lot having a front footage of less than sixty (60) feet, or no lot having an area of less than six thousand square feet,
- 2. No building shall be erected, placed, or altered on any lot until the construction plane and specifications and a plan showing the location of the structure have been approved by the Architectural Committee.

- 4. The ground floor area of the main structure, exclusive of open porches and garages, shall not be less than one thousand two hundred (1,200) square feet. It is expressly provided that no exterior walls of any dwelling unit shall be constructed of asbestos shingles, concrete blocks or stucco. The type of exterior walls to be constructed in any dwelling unit must be approved in writing by the Architectural Control Committee before construction is begun.
- 5. Easements for installation and maintenance of utilities and drainage facilities are reserved as shown on the recorded plat.
- 6. No building shall be erected, placed or altered on any building plot in this subdivision until the building plans, specifications and plot plans showing the location of such buildings have been approved in writing as to conformity and harmony of external design with existing structures in this subdivision, and as to location of the building with respect to topography and finished ground elevation by the committee composed of Verlan Prichard and Robert E. Tresch, or by a representative designated by this committee. In the event of death or resignation of any member of said committee, the remaining member, or members, shall have full authority to approve or disapprove such design or location, or to designate a representative, with like authority. In the event said committee, or its designated representative, fails to approve or disapprove such design and location within thirty (30) days after said plans and specifications have been submitted to it, or, in any event, if no suit to enjoin the erection of such building or the making of such alterations have been commenced prior to the completion thereof, such approval will not be required and this covenant shall be deemed to have been fully complied with. Weither the members of such committee, nor its designated representative, shall be entitled to any compensation for services performed pursuant to this covenant. The powers and duties of such committee, and of its designated representative, shall not be required unless, prior to said date and effective thereof, a written instrument shall be executed by the then record owners of a majority of the lots in the subdivision and duly recorded, appointing a representative, or representatives, who shall thereafter exercise the
- 7. No noxious or offensive trade or activity shall be carried on upon any residential lot nor shall anything be done thereon which may be of become an annoyance or nuisance to the neighborhood.
- 8. No spiritous, vinous, or small or sedicated bitters capable of producing intexication shall ever be sold, or offered for sale on said property or any part thereof, nor shall said property or any part thereof be used for illegal or issnoral purposes.
- 9. No trailer, basement, tent, shack, garage, barn or other outbuilding shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence; except that builders actually engaged in the construction of residences on any of the property shall be entitled to erect and maintain temporary buildings necessary in connection with such construction, provided, however, that all such temporary buildings must be removed from the property not later than December 31,1965.
- 10. Main dwellings shall be constructed fronting on the street upon which the let, as originally dedicated fronts.

- 12. No oil drilling, oil development operations, oil refining, quarrying or mining operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, mineral excavations or shafts be permitted upon or in any lot. No derrick or other structure designed for use inboring for oil or natural gas shall be erected, maintained or permitted upon any lot.
- 13. No animals, livestock, or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats or other household pets may be kept provided that they are not kept, bred or maintained for any commercial purpose.
 - 14. No individual water supply system shall be parmitted on any lot.
 - 15. No individual aswage disposal system shall be permitted on any lot.
- 16. No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage or other waste shall not be kept except in sanitary containers. All incinerators or other equipment for the stora or disposal of such material shall be kept in a clean and sanitary condition.
- 17. We fence, wall, bedge or shrub planting which obstructs sight lines at elevations between two (2) and six (6) feet above the readways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street property lines and a line connecting them at points twenty-five (25) feet from the intersection of the street lines, or in the case of a rounded property corner from the intersection of the street property lines extended. The same sight-line limitations shall apply on any lot within ten (10) feet from the intersection of a street property line with the edge of a driveway or alley pavement. No tree shall be permitted to remain within such distances of such intersections unless the foliage line is maintained as sufficient height to prevent obstruction of such sight lines.
- 18. The foregoing restrictions shall be applicable to all lots shown on the recorded map of Lazybrook Addition above referred to.
- 19. These covenants are run with the land and shall be binding on all parties and all persons claiming under them for a period of twenty-five (25) years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive periods of ten (10) years unless an instrument signed by a majority of the then owners of the lots, has been recorded, agreeing to change said covenants in whole or in part. Enforcement shall be by proceedings at law or in equity against any person or persons violating or attempting to violate any covenant, either to restrain violation, or to recover damages.
- 20. Invalidation of any one of these covenants by judgment or court order shall in no vise affect any of the other provisions which shall remain in full force and effect.
